**EXTENSION OF ADHOC APPOINTMENT OF SECTION OFFICERS**


Approval of the Competent Authority has been accorded for extension of adhoc appointment in respect of Section Officer (Gp 'B' Gazetted) in the Grade Pay of Rs. 4800/- (Pay Band 2: Rs. 9300-34800), mentioned in the enclosed Annexure for a period upto 09.04.2015 or till they retire or till the regular incumbents become available, whichever is earlier, subject to the conditions given below:-

(a) These appointment are made purely as a stop gap arrangement and can be terminated without any notice for administrative reasons or on availability of regular incumbents;

(b) The adhoc appointment will not bestow on these officers a claim for appointment to the above post on regular basis; and,

(c) The service rendered as Section Officer on adhoc basis would not count for seniority in that grade and for eligibility for promotion to the next higher grade.
