EXTENSION OF ADHOC APPOINTMENT OF SECTION OFFICERS

Approval of the Competent Authority has been accorded for extension of adhoc appointment in respect of Section Officers (Group 'B', Gazetted post in the Level 8 of Pay Matrix (pre-revised Grade Pay of Rs. 4,800/- in PB-2), mentioned in the enclosed Annexure for a period upto **30.04.2021** or till they retire or till the regular incumbents become available, whichever is earlier, subject to the conditions given below:-

- (i) These appointments are made purely as a stop gap arrangement and can be terminated without any notice for administrative reasons or on availability of regular incumbents;
- (ii) The adhoc appointment will not bestow on these officers a claim for appointment to the above post on regular basis; and,
- (iii) The service rendered as Section Officer on adhoc basis would not count for seniority in that grade and for eligibility for promotion to the next higher grade.
