**Sub: Grant of First (1<sup>st</sup>) / Third (3<sup>rd</sup>) Financial Upgradation under MACP Scheme to Group 'C' Canteen Employees of Departmental Canteen in AFHQ/ISOs, M/o Defence.**


As per the provisions of MACP Schemes issued vide DOP&T O.M. Nos. 35034/3/2008-Estt.(D) dated 19 May 2009 and 35034/3/2015-Estt.(D) dated 28 Sep 2016, the Competent Authority has approved the grant of 1<sup>st</sup>/3<sup>rd</sup> Financial Upgradation (FU) under the MACP Scheme to the officials of Departmental Canteen in AFHQ/ISOs, Ministry of Defence with effect from the date shown against them as mentioned at Annexure 'A' to this note.

2. As per DOP&T clarification vide ID No. 32536/CR/11 dated 18-01-12, the dies-non will not be counted as regular service for the purpose of ACP/MACP scheme. Hence, in case of Sh. Bhim Singh, Clerk (Sl. No. 03) and Shri William, Canteen Attendant (Sl. No. 08), the date of grant of 3<sup>rd</sup> FU has been extended beyond 30 years because of the Dies-non period during the service of these officials.

3. The financial upgradation shall be purely personal to the officials and shall have no relevance to their seniority position. As such, there shall be no additional financial upgradation for the senior official on the ground that the junior official in the grade have got higher pay under the Scheme.

4. The officials have an option under FR 22 (1) (a) (1) to get his pay fixed in the next Level as per provisions of 7<sup>th</sup> CPC. There shall, however, be no further fixation of pay at the time of regular promotion.

5. The above upgradation will be further subject to the terms and conditions stipulated in DOP&T OMs on the subject of Modified Assured Career Progression Scheme, as amended from time to time.
