Sir,

I am directed to refer to this office Note No. A/47921/DPC-II-2010/Asstt/CAO/P-1(115) dated 23 December, 2010 (copy enclosed) thereby issuing a Supplementary Select List containing the names of 530 UDCs for promotion to the grade of Assistant of AFHQ Civil Service and to say that the UDCs as per list attached of AFHQ Clerical Service who are on deputation have been empanelled for promotion to the grade of Assistant in AFHQ Civil Service in PB-2 with Grade Pay of `4600/- based on his/her seniority in the grade of UDC. He/she may, therefore, be relieved of his/her duties and directed to report to this office for assumption of appointment in the grade of Assistant expeditiously.

2. A proforma of option to be exercised by the official on deputation is enclosed. The individual may be advised to give his/her option which may be forwarded to this office at the earliest. If the individual opts to come back to the cadre immediately, he may be relieved immediately (preferably, on or before 31 December 2010) to avoid any financial loss to him/her. In case, the borrowing organization intends to retain the individual in public interest and is willing to accommodate him in a scale (i.e. in PB-2 with Grade Pay `4600/-) in which he is being granted promotion in parent cadre, proforma promotion can be allowed to the individual provided conditions as laid down under Next Below Rule are satisfied. In case of grant of proforma promotion, the official will be allowed to complete his normal deputation period/already extended tenure.

3. Attention of your Department/Office as well as the official concerned is also drawn to para 8.6, 8.6(a) and 8.6(b) of the consolidated instructions on deputation issued by DOP&T issue vide OM No.6/8/2009-Estt (Pay. II) dated 17 June 2010, wherein conditions for promotion and fixation of pay after promotion, while on deputation has been deliberated.
