2. Consequent to inclusion in the select lists for promotion to the grade of PPS for the panel years 2019 (Review Cum Supplementary) & 2020 (Regular), the individuals (PSs) mentioned in Annexure 'A' & 'B' to this note are hereby promoted to the grade of Principal Private Secretary (PPS) in Level -11 as per VIIth CPC (pre-revised Grade Pay Rs.6600/-) (Group 'A' Gazetted) on regular basis and posted to organisations mentioned against their names.
3. Promotions of the officers will be effective from the date of issue of this order or assumption of charge of higher grade, whichever is later.
4. As per the AFHQ Stenographers' Service Rules 2004, amended vide SRO 29 dated 18th April 2012, all the PPSs promoted vide note under reference will remain under probation for a period of two years wef the date of promotion. This period can be extended at the discretion of the Competent Authority. Two Assessment Reports duly filled, first at the completion of one year and second at the completion of second year, may be forwarded to CAO/APAR (P-2) Cell.
5. The pay of the officers shall be fixed as per existing instructions on the subject matter.
6. The promotion order will be subject to outcome of Hon'ble Supreme Court order on reservation issue in terms of DoP&T OM dated 15 Jun 2018.
