2. Consequent to inclusion in the supplementary panel for the year 2013-14 issued vide Note of even number dated 27th May 2014, Personal Assistants (PAs) mentioned at Appendix 'A' to this Note are promoted to the grade of Private Secretary (PS), Group 'B' Gazetted in PB-2 (₹ 9,300-34,800/-) with Grade Pay ₹ 4800/-, and posted to organisations mentioned against their names.
3. Promotions of the abovementioned officers will be effective from the date of issue of this order or assumption of charge of higher grade, whichever is later.
4. **The Pay of the officials may be fixed in the grade of Private Secretary in terms of provisions laid down under FR-22, as amended from time to time and the instruction stipulated in CCS (RP) Rules, 2008.** However, those officers, who have already exercised this option under MACPS, need not be given this facility.
