Subject: **Promotion to the grade of Director (in-situ) of AFHQ Civil Service**

Reference Govt. Order No. A/26041/VICPC/CAO/CP dated 22.10.2014 regarding Cadre Restructuring of AFHQ Civil Service.

2. The undersigned is directed to convey the approval of the Competent Authority to the appointment of 22 officers of the level of Joint Director (Pay Band-3 with Grade Pay ₹7,600/-) to the level of Director (in-situ) (Pay Band-4 with Grade Pay ₹8,700/-) of AFHQ Civil Service, as per Appendix 'A' attached.

3. The in-situ appointment of these 22 officers is subject to the following conditions:-

(a) The appointment to the grade of Director (in-situ) will be personal to the incumbents holding the post of Joint Director and will be effective from the date of issue of this Order or assumption of charge whichever is later;

(b) The appointment to the grade of Director (in-situ) will not entitle the officers to any claim for regular appointment as Director or seniority in the grade of Director;

(c) Pay fixation of the officers in the higher grade will be done in terms of the provisions laid down under FR 22 and the instructions stipulated in CCS(RP) Rules, 2008 while making similar appointments i.e. as Director on regular basis; and,

(d) The officers appointed to the grade of Director (in-situ) will be given the designation (i.e. of Director (in-situ)) and the scale of pay of the post but will continue to perform the same duties/ functions as they are doing at present;

4. The in-situ appointments are non-functional upgradations per se and do not involve any change in the existing Command and Control and Level/ Channel of Reporting. Officers appointed on in-situ basis will not be posted against regular post of Director.

5. The officers appointed on in-situ basis will not be entitled to the local designation given to the incumbents of regular post of Director in Headquarters/ Branches/ ISOs.
6. As regards the officers who are on deputation/ leave, the benefit shall be given on their return to duty from deputation/ leave.
7. Charge assumption reports may be forwarded to all concerned.
