3. Promotion of the officer will be effective from the date of issue of this order or assumption of charge of higher grade, whichever is later.



Concerned Administrative Section is requested to ensure timely submission of blank Assessment Report forms of the official to the user office for completion.

5. **The pay of the official may be fixed in the grade of System Analyst in terms of provisions laid down under FR-22, as amended from time to time and the instructions as stipulated in CCS (RP) Rules, 2016.**
