The DEO 'B' promoted to the grade DPA 'A' vide para 02 above will be on probation for a period of 02 years from the date that he assumes the appointment of DPA 'A' as per the provision of Recruitment Rules. Assessment reports for 1st & 2nd years of probation in respect of DPA 'A' may be sent to CAO's office, address to Admin officer, CAO/APAR (P-2) Cell immediately on completion of 1st & 2nd year respectively. Concerned Administrative section is requested to ensure timely submission of blank Assessment Report forms of the official to the user office for completion. Promotion of the officer will be effective from the date of issue to this order or assumption of charge of higher grade, whichever is later.

4. **The pay of the official may be fixed in the grade of Data Processing Assistant Grade 'A' (DPA 'A') in terms provisions laid down under FR-22(I)(a)(1), as amended from time to time and the instruction stipulated in CCS (RP) Rules, 2016.** However, if the officer have already exercised this option under MACPS, need not be given this facility.

5. As per DoP&T OM No. 36012/11/2016-Estt.(Res-I){Pt-II} dated 15 Jun 2018, the promotion of the above official shall be subject to further orders which may be passed by the Hon'ble Supreme court.
