APPOINTMENT OF SECTION OFFICER AS DEPUTY DIRECTOR
ON ADHOC BASIS

Approval of the Competent Authority has been accorded to the appointment of the Section Officers of AFHQ Civil Service, as per Annexure enclosed, as Deputy Directors (Group `A' Gazetted) on adhoc basis in the Grade Pay of ₹. 6,600/- (Pay Band 3: ₹.15600-39100) with immediate effect for a period upto 25-04-2013 or till he retires or till the regular incumbents become available or until further orders whichever is earlier, subject to the conditions given below :-

- a) The appointment will take effect from the date the officer assumes the charge of higher post;
 - b) The appointment is made purely on adhoc basis and that such appointment will not bestow on the person a claim for regular appointment ; and,
 - c) The service rendered on adhoc basis in the grade of Dy Director would not count for the purpose of seniority in that grade and of eligibility for promotion to the next higher grade.
2. They are posted against existing vacancies in the Headquarters/Branches/ISOs as indicated against each in the Annexure ibid.
 3. The adhoc promotion to the grade of Dy Director is further subject to the outcome of OA No. 2145/2011 and MA No 1622/2011 filed by Shri Mohinder Singh & Ors. Vs. UOI & Ors. before the Hon'ble CAT (PB), New Delhi.
