2. Based on the Select List for the year 2011-12 issued vide Note under reference, Assistants, as per Annexure enclosed, is appointed to the grade of Section Officer (Group 'B', Gazetted post in the Grade pay ₹ 4,800 in PB-2) on regular basis. Their regular appointment as Section Officer will be deemed to be effective w.e.f. 01.04.2011 and they will be entitled to get the benefit of Pay Fixation under FR 22.

3. All the officers are retained in the same Headquarters/Branches/ISOs where they are presently posted, on their promotion as Section Officer on regular basis.

4. These Officers will be on probation for a period of 2 years from the date from which they are appointed on regular basis, which may be extended at the discretion of the Competent Authority. Assessment Reports for the first year of probation in respect of these Section Officers may be sent to CAO's Office, addressed to Sr. Administrative Officer, CAO/APAR Cell immediately on completion of first year and the report of second year immediately on completion of second year. Administrative Sections of CAO's Office and Establishment Section of Air HQ and Naval HQ are requested to ensure timely submission of blank Assessment Report forms of the officials to the user offices for completion, under intimation to this office.
