Subject: **Promotion to the grade of Section Officer based on qualifying Limited Departmental Competitive Examination, 2008 (for SO/ PS [Gp-B/ Gr-I])**

With the approval of the Competent Authority, the 33 Officers as per Appendix to this note are appointed to the grade of Section Officer (Group 'B' Gazetted) on regular basis (Pay Band-2: ₹ 9,300-34,800; Gde Pay ₹ 4,800) in AFHQ Civil Service, based on the final results of the Limited Departmental Competitive Examination-2008 for SOs/Stenos [Gp-B/Gr-II].

2. The Officers at Sl. Nos **13, 18, 26, 29, 30, 31 & 33** of the Appendix who are already working as Section Officer on Adhoc basis are retained in their present offices. Their appointment in the grade of Section Officer stands regularized. The remaining Officers are, hereby, posted to the offices mentioned against their names on their appointment as Section Officer on regular basis. The promotion to the grade of Section Officer will take effect from the date of charge assumption in that grade.

3. In accordance with Rule 10 (I) (1) of AFHQ Civil Service Rules, 2001, all officers will be on probation for a period of two years from the date of their assumption of charge as Section Officer on regular basis. Admin Sections are requested to ensure timely submission of blank assessment report form of the officials to the user office for completion, under intimation to this office.

4. The Officers may also be advised to exercise their option for fixation of pay within stipulated period in terms of the provisions laid down under FR-22, as amended from time to time.

5. The Officers who have been transferred from their present office on promotion may be relieved of their duties immediately and directed to report to their new place of posting. The relieving/charge assumption reports may be sent to all concerned.

6. The Officers except those who have already undergone Assistant Refresher Course during the year 2010-11 or thereafter are detailed for a five day Orientation Course at DHTI as per the following schedule:

From Srl No 1 to 15 - 14 – 18 Nov 2011

From Srl No 16 to 33 - 21 – 25 Nov 2011

7. The concerned Offices are requested to relieve the officers detailed for training.
