2. The duration of outstation posting in respect of all the officials will be 5 years. As this is an outstation posting which has been issued on the basis of request received in response to vacancy circular issued by this office, requests for deferment/change/cancellation of posting will not be entertained.
3. The above officials will have to move from their present office to their new place of posting by 30 Sep 2018, however, Shri P Anantha Sayanam, PA may be moved by end of Apr 2019 as requested by him. In case, they are not relieved, this office will be constrained to relieve them unilaterally under the powers of the Cadre Controlling Authority, without issuing further reminder. Disciplinary proceeding will be initiated against the official, if he/she fails to move on receipt of the unilateral order.
4. Before relieving the above official, it may be ensured that he/she completes his/her self-appraisal of the APAR form, to be provided by the concerned Admin/Coord Sections and submits it to the Reporting Officer.
5. The above officials will be entitled for joining time and TA/DA etc, as admissible under the rules, as the posting/transfer is in public interest and the move is of permanent nature.
