Sub: **59th NDC Course at National Defence College, New Delhi commencing on 7th January, 2019.**

1. The 59th NDC Course at National Defence college, New Delhi is due to commence on 7th January, 2019.
2. Guidelines/QRs laid down by Ministry of Defence for the course are as under:
 - (a) IAS/IPS/IFS officers having 14 year of completed service.
 - (b) Officers of other Central Civil Service of the rank of Senior Deputy Secretary/Director of a Central Ministry or equivalent who are likely to reach policy making level of Joint Secretary or equivalent having not less than 16 years of completed service.
 - (c) Below 50 years of age as on 01 Jan 2019, with sound physical and mental health.
 - (d) Excellent record of past performance.
 - (e) Clearance from Vigilance and disciplinary angle.
3. It has further been stipulated by Ministry by Defence that the officers should not have undergone a training programme of **12 weeks or more duration in India during a period of 5 years** preceding the date of commencement of this course. Further, the officer should not have undergone a programme of training abroad of more than **2 weeks in preceding 2 years, more than 1 month in the preceding 3 years or more than 6 months in preceding 5 years.**
4. **Course Fee:** The details of course fees are:-

Tuition Fee	Rs. 2,10,000/-
Internal and Foreign Tours	Rs. 20,00,000/-

DHTI will be able to bear the tuition fee of nominated officers out of the allotted budget for training in the FY 2018-19. However, the budget for internal and foreign tour has to be provided by Service headquarters whose participant is finally nominated for NDC after approval of the competent authority.

5. AFHQ Civil Service Officers of the rank of Director and Joint Director below 50 years of age as on 01st Jan 2019, desirous to attend the course may apply in the prescribed proforma. The application, duly filled in and recommended by the controlling officer, should reach this office by **20th Aug 2018** positively. Application received after due date will not be entertained.
6. It may please be noted that selection of the nominee will be as per the prescribed eligibility criteria by the competent authority in Ministry of Defence.
