Sub: TWO YEAR FULL TIME POST-GRADUATE DIPLOMA IN MANAGEMENT (FINANCIAL MANAGEMENT) COURSE COMMENCING IN JULY/AUG, 2020.

1. The National Institute of Financial Management (NIFM), Faridabad (Haryana) will conduct two years' full time Post-Graduate Diploma in Management (Financial Management) [PGDM (FM)] in July/Aug 2020. The programme is recognized by All India Council of Technical Education (AICTE).
2. The programme embodies sensitization of the participants to the contemporary concerns facing the country and the government in particular, besides the corporate world. The program addresses the key issues in Public Financial Management in an Information Technology enabled scenerio. Besides class-room teaching for conceptual and theoretical orientation of the participants, the program focuses on experience sharing and shared learning through a variety of interventions such as case method, panel discussions, presentations, seminars etc.
3. The eligibility criteria laid down by the Institute are as under:
 - (a) All participants must have completed Graduation or a Degree equivalent thereto from an India/Foreign University (Institution) recognised by the Association of Indian Universities, Ministry of HRD, Government of India. Minimum percentage of marks at graduation level must be 50%
 - (b) The upper age limit for all participants is 50 years on the last date of submission of application form for the programme i.e **30 Jun 2020**.
 - (c) The officer should be working at middle/senior level in their respective organisation with work experience of at least three years.
4. AFHQ Civil Service Officers (Group 'A') below 50 years of age as on 30 Jun 2020, who are desirous to participate in the above mentioned programme, may apply in the prescribed application form. The application, duly filled in and recommended by his/her Controlling Officer, should reach this office by **15 Jun 2020**. All supporting documents i.e., certificate and mark sheet showing minimum educational

qualification required and date of birth should be enclosed along with the application. Applications received after due date will not be entertained. Applicants are also requested to carefully study course brochure available at NIFM website before applying

5. It may please be noted that selection of the nominee will be as per the prescribed eligibility criteria laid down by NIFM, Faridabad.

Dear Sir,

As you are aware, the Arun Jaitley National Institute of Financial Management (NIFM) located in Faridabad, NCR [outskirts of New Delhi], is a Centre of Excellence, specializing in training of professionals in the fields of Public Policy, Financial Management, Public Procurement and other governance related issues for promoting highest standards of professional competence and practice. It is a premier resource centre for the capacity building of senior, middle and entry level of managers. Training Programs are customized and executed for officials from other countries as well.

Through this letter we may inform you that the Institute is now in the process of inviting applications for its two-year Post Graduate Diploma in Management (Financial Management) – PGDM (FM). The Program is approved by All India Council for Technical Education (AICTE) and Association of Indian Universities (AIU) of Ministry of Human Resource Development (MHRD), Government of India. The 2-Year program has a short component of two weeks' international attachment, which seeks to provide participants with an exposure to the best international practices in the field of Public Financial Management and other contemporary topics addressing Core Issues of Governance. The Program also has a domestic attachment of one-week, which aims at giving exposure to one of the key financial institutions within the country.

You may please be informed that over the years, over 200 Officers of various State Governments have attended this Program up to 2019-21. The Program has been well received, and the participants have benefited from the classroom discourse, besides interaction with diverse and experienced peer group. NIFM now seeks the nomination of suitable officers for its PGDM (FM) 2020-22 Program. The program focuses on admitting preferably mid-level serving officers of Government, both Centre and State, Central and State PSUs, and various autonomous bodies under national and sub-national governments.

The DHTI has nominated close to 15-18 officer since the commencement our program in 2000. You may please be informed that other state governments, including special category and north-eastern states have together sent close to 200 officers in the past; and the Central Government by now has sponsored over 1000 officers.

The course fee for the Program is borne by the Government of India.

The financial liability of the nominating/sponsoring department is limited to the financial provisions for (i) salary/allowances (as per rule/applicability); (ii) expenses towards travel/transport & D.A. during domestic attachments; and (iii) daily subsistence allowance (DSA) during international attachment of the sponsored officer.

Applications of interested officers may be considered and sent to NIFM before the extended date i.e. 30th June 2020.

The applicants may however be asked to send their advance copy of their applications, pending the final applications to be sent through proper channel (by their HoD / cadre authorities) to NIFM. The nominations would be processed by NIFM in June 2020.

The selected officers would be expected to join the program in July/August 2020.

Specific date shall be communicated in due course.

We look forward to welcoming nominees from your State to the PGDM (FM) 2020-22.

The Program shall commence w.e.f. July/August 2020.
