Post & Classification : Data Entry Operator, Grade 'D'  
General Central Service,  
Group 'B', Non-Gazetted, Non-Ministerial

Pay Scale : : Pay Band 2, ₹9300-34800 plus Grade Pay of ₹ 4200/-

Eligibility Condition : **Deputation** :-  
Officers of the Central Government

(A) (i) holding analogous posts on regular basis:

or

(ii) with six years service in the grade rendered after appointment thereto on regular basis in the Pay Band-1 ₹ 5200-20200 with grade pay of ₹ 2800; and

(b) possessing Bachelor's degree with Mathematics or Statistics or Mathematical Statistics or Science (with Physics as a main subject) or Computer Science or Electronics or Computer Programming as one of the subjects from recognised University and a speed of not less than 8000 Key Depressions per hour for Data Entry Work, and

(c) Three years working experience relating to data analysis in computer from any recognized Institute or organization.

**Job Profile:-** Analysis and study of the simple tasks assigned to him. Routine analytical work and clearance of the output of the results of operational research. Assisting in the periodical destruction of the obsolete classified documents/materials.

3. The speed of 8000 Key Depressions per hour for Data Entry Work is to be judge by conducting a speed test on the Electronics Data Processing machine(s) by the Central Government.

4. The departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation and similarly, deputationists shall not be eligible for consideration for appointment by promotion.

5. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications. The appointment on deputation shall be governed by the terms and conditions laid down in Department of Personnel & Training No 6/8/2009-Estt. (Pay-II) dated 17 Jun 2010 and its subsequent amendments, if any.

6. For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1<sup>st</sup> January, 2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission, except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.

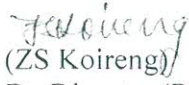
