

VACANCY CIRCULAR FOR DEPUTATION POST

Reference vacancy circular No.1/31/2014/VWDT/960 dated 17 Jan 2018 inviting application for filling up the post of Assessor, Registrar, Principal Private Secretary, Executive Engineer, Private Secretary and Personal Assistant in Vansadhara Water Disputes Tribunal (VWDT) on deputation basis (copy enclosed).

2. Willing and eligible officers of AFHQ cadre, who can be spared in the event of their selection, may submit their application through their Admin/Estt Sections.
3. While forwarding the application(s), the Admn/Estt section should ensure that the applicants fulfill the required eligibility criteria/condition prescribed for the posts. They are also requested to verify and confirm that the particulars mentioned by the applicants are correct. They may also confirm that no disciplinary / vigilance case is pending/being contemplated against them and that no penalty, major or minor, has been imposed on the individual in the past and the individual is not currently undergoing any penalty.
4. Officers, who volunteer for the post, will not be permitted to withdraw their candidature later, under any circumstances.

The terms and conditions of appointment will be regulated under the DOP&T O.M.No.2/29/91-Estt. (Pay.II) dated 17-6-2010 as amended from time to time. Application duly filled in as per Proforma along with C.R. dossiers and the latest vigilance clearance certificate of the eligible candidates (in the case of serving officers) may be forwarded by the Organisations/Departments concerned to the Registry, Vansadhara Water Disputes Tribunal, 5th Floor, Mohan Singh Place, Baba Khark Singh Marg, New Delhi – 110 001 on or before 06-03-2018. Selected candidates shall not be allowed to withdraw their candidature. Incomplete application shall not be considered.
