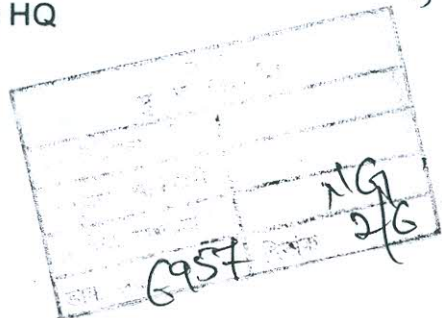

Agenda Point No VIII: Simplification in Procedure of Options of Area for Allotment of CAO Pool of Accommodation (Sponsored by ADG LWE)

23. The agenda points was discussed during PSOC meeting dated 15 Dec 2016, As the present system of specifying choices is extremely complicated, Army HQ had proposed streamlining of procedure as enumerated below :-

- (a) All officers be permitted to specify only one choice of area on arrival rather than keeping it open ended.
- (b) Subsequently, two changes to the specified area be permitted prior to officers' name appearing in offer letter and being allotted an accommodation.
- (c) Present stipulation of one change per year be discontinued with.
- (d) Option of applying for change of area, after residing in the allotted accommodation for six months be discontinued with.

24. The Committee decided that Air Force & Naval HQ to examine the proposal and forward their comments within 30 days of PSOC meeting and consequently the agenda be discussed in next PSOC meeting. The proposal of discontinuing with option of applying for change of area, after residing in the allotted accommodation for six months was not agreed to.

25. Comments from Naval HQ on the Agenda are as enumerated below:-

- (a) All officers be permitted to specify only choice of area on arrival rather than keeping it open ended.
- (b) Two changes to the specified choice area be permitted prior to officer's name appearing in offer letter and he being allotted an accommodation.
- (c) Stipulation of only one change per year to be discontinued.
- (d) The option of applying for change of area, after residing in the allotted accommodation for six months be continued with.

26. **Discussion.** The Air Force agreed to the proposal as at Para 25 above.

27. **Decision.** After due deliberation the committee decided that henceforth officers registered for MoD pool accn may be permitted to specify only one area choice, instead of three area choices as per the existing norm. Subsequently, two changes to specified area be permitted prior to officer's name appearing in offer letters.
