In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Ministry of Defence, Integrated Headquarters of Ministry of Defence (Army), Directorate General of Information Systems, Management Information System Organisation (MISO) Group 'A' and 'B' posts (Senior System Analyst) Recruitment Rules, 2017 except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Senior System Analyst Group 'A' posts in the Integrated Headquarters of Ministry of Defence (Army), Defence Staff Headquarters, Directorate General of Information Systems, Management Information System Organisation (MISO), namely:-

- 1. Short title and commencement.- (1) These rules may be called the Ministry of Defence, Integrated Headquarters of Ministry of Defence (Army), Directorate General of Information Systems, Management Information System Organisation (MISO) Group 'A' post (Senior System Analyst) Recruitment (Amendment) Rules, 2018.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Integrated Headquarters of Ministry of Defence (Army), Directorate General of Information Systems, Management Information System Organisation (MISO) (Group 'A' post) Defence Staff Headquarters, Recruitment Rules, 2017, for the post of Senior System Analyst at Sl. No.2 in Column 11, under the sub-heading "Promotion" and entries below it, the following entries shall be substituted:-

Data Processing Assistant (erstwhile Programmers) in Level-7 in the Pay Matrix with seven years regular service in the grade subject to successful completion of Two to Four weeks training from Centre for Development of Advanced Computing or any other Government organisation by the User Organisation.
