**Sub :- Notices for All India Indefinite Strike call on 11.07.2016 by various Unions/Associations affiliated to AIDEF & INDWF in pursuance of their Charter of Demands – DOP&T's instructions – regarding.**

Many Unions/Associations affiliated to Federations, namely, AIDEF, INDWF etc. have given Strike Notices addressed to their respective Head of Offices where they are functioning, with a copy being endorsed to the higher authorities in MoD, on the above subject.

2. In this context, kind attention is invited to the relevant instructions contained in DOP&T's O.M. No. 33012/1(s)/2008-Estt(B)(pt) dated 12.09.2008 to deal with such cases, a copy of which is enclosed for information and appropriate necessary action, which prohibits the Govt. Servants from participating in any form of strike including mass casual leave, go-slow etc. or any action that abet any form of strike in violation of Rule 7 of the CCS (Conduct) Rules, 1964. The Supreme Court has also agreed in several judgments that going on strike is a grave misconduct under the Conduct Rules.
