Sir,

Cabinet Secretariat urgently requires services of eligible officials on deputation basis, to fill up some vacancies in different ranks in **Departmental Canteen** as per details mentioned in **Annexure-I**.

2. The period of deputation will be three (03) years and while on deputation the officials will be governed by the provisions as laid down in DoP&T O.M. No. 6/8/2009-Estt (Pay-II) dated 17/6/2010 as amended from time to time. In addition, they will be entitled to a Special Security Allowance @ 20% of basic pay.
3. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Govt. should not exceed 03 years.
4. The departmental officers in the feeder category, who are in the direct line of promotion, shall not be eligible for consideration for appoint on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.
5. The maximum age limit for appointment by deputation shall not be exceeding fifty six years as on the closing date of receipt of applications.
