Sub : **Introduction of Non Functional scale of Rs. 8000-275-13500  
to Section Officers of Armed Forces Headquarters Civil  
Service (AFHQ CS)**

I am directed to refer to Government of India, Ministry of Personal, PG & Pensions letters No. 21/36/03-CS.I dated 13 Nov 2003 and 5/4/2005-CS-I dated 25 Jan 2006 to convey the sanction of the President for extending the provision thereof, to the Section Officers of AFHQ CS at par with the Section Officers of the Central Secretariat Service (CSS) i.e. notionally w.e.f. 1.1.1996 with actual benefits being granted from 3.10.2003.

2. The cadre controlling authority of AFHQCS has accordingly consented to grant the Non-Functional Scale of Rs. 8000-275-13500 to the Section Officers of AFHQCS, in accordance with the following parameters :-

(a) The Non Functional Pay Scale of Rs. 8000-275-13500 is admissible to the Section Officers of Armed Forces Headquarters Civil Service (CS) on completion of 4 years of approved service in that grade, subject to their vigilance clearance.


(b) Though the notional pay fixation of the eligible officers will be done w.e.f. 01.01.1996, actual benefits will accrue to them w.e.f. 03.10.2003.

(c) On account of such pay fixation, the officers would be entitled to draw arrears of pay w.e.f. 03.10.2003.

(d) The Section Officers, who are granted this non-functional pay scale of Rs. 8000-275-13500 will continue to remain in Group 'B' (Gazetted) and their eligibility for promotion to the Grade of Deputy Director of AFHQ Civil Services in the pay scale of Rs. 10000-15200 will be reckoned on the basis of total period of service spent in both the pay scales viz. Rs. 6500-10500.(pre-revised) and Rs. 8000-13500, counted together.

- (e) Such officers who are placed in the above Non Functional Scale will be entitled to the benefit of pay fixation under F.R. 22(I)(a)(2) and as per the latest applicable instructions of the Government, thereon.
3. Necessary amendments to the AFHQ Civil Service Rules will be issued separately.
4. This issues with the concurrence of the Ministry of Defence(Finance) vide their U.O. No. 987/MO/08 dated 25/09/2008.
