ISSUE OF TEMPORARY PASS IN LIEU OF DAMAGED SLIC

1. It is stated that the safe custody of Identity Documents is the personal responsibility of the holder. Any one who either alters, misuses, defaces, damages, tampers with the document is liable to be charged as per General Instructions, Oct 2007.

2. In this connection, it is also stated that as per Sub-para 29 (e) of General Instructions, Oct 2007, change of SLIC is carried out without any fee in the following conditions:-

“In the event of loss/mutilation etc of the SLIC on account of natural calamities like flood, cyclone, grave fire accident or arson, loot and riots wherein it was beyond the individual's control to protect the Identity document in his possession.”

3. However, it has been observed that many employees holding SLICs with validity 31 Jan and 31 Jul 2015 are approaching Security Office after tampering their SLICs to get fresh SLIC with extended validity of 31 Mar 2016. Since the number of SLIC is restricted, financial implication will occur if the required number of SLIC exceeds beyond the concurred limit.

4. The employees are trying to use this kind of unfair means to get extended validity of SLIC with a view to get bank loans and other facilities by using the photocopy of the SLIC which is strictly prohibited according to Para-5 (a) of Section-II, Chapter-8 of Manual of Security Instructions, 2008. This deliberate attempt of using the photocopy of SLICs for personal use is a serious security concern.

5. Keeping in view the above, it has been decided by the Competent Authority that a Temporary Pass will be issued to the defaulter in lieu of damaged SLIC where the damage of SLIC is determined on account of negligence/ malafide intention on the part of the individual, till the renewal of SLIC with new bio-metric cards takes place.
